Tendency to place children in institutions—Decisions of juvenile courts influenced by unsatisfactory home conditions—Upper and middle-class values of respectability—Disadvantages of removing children from home—Difficulties of adjustment to home environment on return—Environment in institutions often worse than home environment—Solution of sending to institutions too easy—Family should be dealt with as a whole—Problem of sending children to hospital.

Neurosis in children often noticed only when they have occasion to be charged—Child welfare workers and teachers should be able to recognise symptoms of neurosis—Symptoms of neurosis in children: special schools should be provided to suit the individual needs of difficult children—The same neurotic symptom may have many causes—Psychoanalytical examples and explanations of neuroses in children.
